






### Affiliates by Region

# 5 Our Work in a Nutshell

## Weathering the Storm: Rebuilding for a Stronger Future

After weathering the financial challenges posed by the COVID-19 pandemic and the deficit from the Organic World Congress (OWC) 2021 in France, we entered a period of recovery in 2023 and 2024. We are deeply grateful to our regional bodies for their unwavering support, and the donors and partners for believing in us. A key milestone in our recovery was securing a new host for OWC 2024 after it became evident that Tunisia would not be the host. Within a short period of time and support from the network, we managed to hold the 21st OWC in Taiwan.

As we regained stability, under the leadership of interim Executive Director Marco Schlüter, we focused on developing an ambitious new

strategy while rebuilding our organisational culture. We emphasised solidarity, accountability, collaboration, and agility, with a renewed commitment to strengthening our members.

A significant step forward was the appointment of Executive Director Ravi R. Prasad in January 2024. With a clear vision, strategic direction, and a strong global network, Ravi is working to enhance our visibility, alliances, and financial resilience.

With a renewed strategy centred on our members, a committed team, and strengthened leadership, we are emerging from past crises stronger, more unified, and ready to drive transformative change.

## Our new Strategy 2024-2034

At the beginning of 2024, we launched our ambitious strategy for the next ten years (2024-2034) to unite our movement and position organic as a solution to global crises of climate, biodiversity, food security and inequality.

Our new strategy<sup>1</sup> sets a clear path to unite members and allies<sup>2</sup>, build new partnerships, and set a global agenda while empowering and supporting the organic movement to drive change worldwide. It rests on two complementary and intertwined pillars to empower and lead the organic movement.

**Our vision** | The widespread adoption of truly regenerative organic food and farming systems, grounded in the principles of organic agriculture: health, ecology, fairness and care<sup>3</sup>.

**Our mission** | We empower, mobilise and lead the global organic movement and its allies to drive transformative change on farms, in markets, in the wilderness, and in policies for the benefit of people and the planet.

## Organic World Congress 2024

From 30 November to 4 December 2024, the organic movement met in person for the first time in six years in Chiayi, Taiwan. The event marked a historic milestone with a turnout of over 500 congress participants from 61 countries. The side events, including the Bio-tours, Pre-conference and Organic Fair combined to attract over 2,000 visitors. The Organic World Congress' (OWC) theme, "Cultivating Organic Solutions for True Sustainability," highlighted innovative and collaborative efforts and commitment among and between organic stakeholders — farmers, producers, researchers, policymakers and advocates towards sustainable food systems on a global scale.

In 2023 and 2024, organic and agroecological family farmers amplified their voices on a global stage. The #IGrowYourFood<sup>1</sup> action day 2024 was launched with a live discussion<sup>2</sup> featuring inspiring speakers, including farmers Pratap Marode (India) and Thales Mendonça (Brazil), young entrepreneur Mercy Manyange (Kenya), and Guilherme Brady from the FAO's

UN Decade of Family Farming initiative. Additionally, #IGrowYourFood videos were showcased at the 2024 World Food Forum as part of the "Innovations for and by Family Farmers" video contest, further highlighting the vital role of family farmers in shaping sustainable food systems.<sup>3</sup>

IFOAM – Organics International is pleased to welcome Taiwan as the latest member of the IFOAM Family of Standards. Following a thorough equivalence assessment, the Taiwan Organic Regulation has been recognised for meeting the Common Objectives and Requirements of Organic Standards (COROS).

The application for inclusion was submitted by the Tse-Xin Organic Agriculture Foundation<sup>1</sup>, with the Agriculture and Food Agency serving as the standard owner in Taiwan. This milestone strengthens the credibility of Taiwan's organic sector while facilitating international market access for producers certified under its organic regulation.

Joining the IFOAM Family of Standards opens new opportunities for Taiwanese organic businesses, including increased acceptance by global organic programmes and participation in leading organic trade fairs such as BIOFACH. It also enhances access to key markets, including Australia and beyond.

# UN Decade of Family Farming Mid-term Forum

In 2024, the Global Family Farming Forum took place at a dedicated Farm Venue outside the Food and Agriculture Organisation (FAO) headquarters as part of the World Food Forum. The space showcased innovative solutions by family farmers, featured a global radio station, and hosted interactive discussions. IFOAM – Organics International and the Inter-Continental Network of Organic Farmers Organisation (INOFO) actively contributed, organising the side event: "Which Public Policies Support Agroecological and Organic Family Farmers?" Representatives from both organisations also spoke in various sessions, advocating for policies that promote agroecology and organic farming in family agriculture.

# Agroecology Promotion Programme: Advancing Resilient and Inclusive Food Systems

Launched in 2024 in partnership with the Swiss Agency for Development Cooperation (SDC), the Agroecology Promotion Programme (APP)<sup>1</sup> is driving the transformation of food systems across Africa and Southeast Asia. In collaboration with regional partners such as Biovision Africa Trust (BvAT) and the Agroecology Learning Alliance in Southeast Asia (ALiSEA), we play a key role in strengthening agroecological practices through Policy Labs, Agroecology and Organic Leadership Courses (AOLCs) and the development of participatory agroecology curricula.<sup>2</sup> This initiative fosters knowledge exchange, capacity building, and policy engagement to create more sustainable and inclusive food systems.

# Capacity Development of Change Agents for Ecological Organic Agriculture in Southern, Central, Eastern, Northern and Western Africa

The initiative is the second phase of the GIZ project, titled *Knowledge Centre for Organic Agriculture (KCOA)* that aims to invest in capacity development of change agents in Southern, Central, Eastern, Northern and Western Africa. Under this framework, a total of 115 Master Trainers, coming from all five African Regional Knowledge Hubs, have received Refresher Trainings based on the demand and needs of each Knowledge Hub.

In 2023, a total of seven Refresher Trainings were implemented in Egypt (KHNA), Tanzania (KHEA), Madagascar (KHEA), Nigeria (KHWB), Cameroon (KHCA) and Namibia (KHSA). This is part of a broader and ambitious initiative to build a network of empowered change agents to deliver trainings in a cascade system (training the trainer format). The initiative also aims to encourage them to step into new challenging fields, explore and unfold their talents to skill and scale up in Agroecology!

The KCOA project continued to thrive in 2024. Its innovative Training of Trainers (ToT) programme empowered over 100 master trainers in the first phase, while the Refresher Trainings enhanced the skills of 150 master trainers in the second phase. By the end of 2024, the cascading system has trained over 1,000 multipliers, strengthening local expertise in organic and agroecological practices.

Additionally, a workshop targeting facilitators and trainers on Advocacy for Agroecology and Organic Agriculture was held, resulting in the development of a dedicated advocacy manual.

### Defending Grower Group Certification for Small-Scale Farmers

In 2024, we reaffirmed our support for grower group certification amid the Pratum vs USDA litigation, which challenged the integrity of this certification model. We emphasised that grower group certification is vital for millions of small-scale organic farmers worldwide, enabling them to access global markets while maintaining rigorous product standards. Recognising differences between the USDA's new regulation for producer groups and both recent EU legislation and IFOAM Norms, we continue to advocate for the recognition and support of group certification to promote sustainable agricultural practices globally.

### Himalayan Agroecology Initiative shapes a Sustainable Food Future

In 2024, the Himalayan Agroecology Initiative (HAI)<sup>1</sup> made significant strides through multi-stakeholder consultations across Nepal, Bhutan<sup>2</sup> and India<sup>3</sup>. These discussions brought together farmers, policymakers, researchers, and civil society to co-develop a roadmap for sustainable, resilient food systems rooted in agroecology. Key themes included policy integration, capacity building, and strengthening local food economies. The consultations emphasised the need for farmer-led innovations, traditional knowledge preservation, and equitable access to resources. This collaborative effort is paving the way for policies that support agroecological transitions, ensuring food security, climate resilience and sustainable livelihoods across the Himalayan region.
